The program is unique and only offered through the International Association of Chiefs of Police and its certified master-and-national-level instructors. Upon completion of this instructional training program the County will have attained the capacity to internally deliver the LPO course to the next class of DeKalb County public safety students. The training curriculum is proprietary and provided to hundreds of police organizations throughout the United States.
