Georgia code 49-3-2(a) indicates that the County governing authority shall appoint members to the DFCS Board. Ms. Mercedes Ball is an assistant director for the State Bar of Georgia, who previously served as an attorney for DeKalb County Child Advocacy Center and would be an asset to the county and those who rely on the services provided through the DeKalb County Department of Family and Children Services.
