**PURPOSE:**

Awarded by the BOC on April 25, 2017 for an amount not to exceed \$6,080,104.65. This contract consists of extending Lithonia Industrial Boulevard south from its intersection with Interstate 20 eastbound ramp to Woodrow Road. On November 13, 2018, the BOC approved CO #1 to extend the contract term through February 28, 2019 to compensate for the time utilized for the redesign of part of the new water line that was originally included in the construction contract. This request is to extend the contract term to March 31, 2019 due to inclement weather which has slowed the pace of construction.

**RECOMMENDATION:**

Recommend approval of Change Order No. 2 with:
