Originally this contract was to provide (25) Ford Vehicles alternative fuel conversion package installation services and alternative fuel repair and maintenance services. On October 09, 2018, the BOC approved Change Order No. 1 for an amount not to exceed \$500,000.00 to purchase alternative fuel vehicles as required by vehicle replacement needs.
