PURPOSE:

Awarded by the BOC on August 28, 2018 for five (5) fire pumpers for an amount not to exceed \$3,391,110.00. Currently, the fleet is operating below the suggested vehicle replacement schedule. There has been a 6% increase in price due to a 2018 Metals Surcharge forced by tariffs on materials and a standard yearly 3% increase due to inflation. These are replacement units under the eight (8) year replacement schedule.
