NEED/IMPACT:

This is a renewal grant of the DUI and Aggressive Driving Enforcement partnership between the DeKalb County Police Department and the Governor's Office of Highway Safety. These funds will be used for salaries as well as operating, training, and travel expenses incurred for Highway Enforcement of Aggressive Traffic (HEAT) operations by DeKalb Police Department officers. Activities are directed towards combating aggressive and impaired driving.
