### PURPOSE:

Awarded by the BOC on December 16, 2014 for an amount not to exceed \$312,000.00. This contract supports the administration of the BFLDP, elite training offered to develop leaders who will help transform government. The training requires a one-year commitment and includes a comprehensive ten-session program designed to develop and prepare employees with leadership potential for higher level opportunities in county government. This request is to extend the contract term to December 31, 2020 and to increase the contract amount.
