The Contract was originally approved in December 2017 by the Board of Commissioners. The 2017 Agenda Item (Agenda Item 2017-1091) incorrectly identified the Contract as an annual contract with options to renew in the title of the relevant RFP and listed the expiration date as December 31, 2018; however, the sample contract included in the RFP and the executed Contract provide that the Contract automatically terminates every December 31, 2022, unless earlier terminated. The correct Contract expiration date is December 31, 2022.
