Traffic Calming Petition - Biltmore Dr between Stephens Dr and Clifton Rd. Cost to the County is \$35,600.00.

PURPOSE:

To consider adopting the attached resolution creating Traffic Calming District 20-18-03 in Land Lots 105 & 106 of the 18th District; to consider authorizing the installation of traffic calming measures (speed tables and center island) and appropriate signage on Biltmore Dr between Stephens Dr and Clifton Rd; to consider assessing all properties in the affected area an annual maintenance cost of \$25.00.

NEED/IMPACT:

Cut-thru has been confirmed on Biltmore Dr between Stephens Dr and Clifton Rd, which meets the criteria for traffic calming measures. Owners of 77.78% of the eligible properties in the identified affected area have signed the petition to have traffic calming measures installed. The public hearing has been advertised and appropriate signs have been posted notifying residents in the area.

FISCAL IMPACT:

The cost of initial installation of traffic calming measures is estimated to be \$35,600.00. All properties in the affected area will be assessed a yearly maintenance cost of \$25.00 during the life of the traffic calming measures beginning the first year after installation.

<u>RECOMMENDATION:</u>

Adopt the attached resolution to create Traffic Calming District 20-18-03 in Land Lots 105 & 106 of the 18th District; and Authorize the installation of traffic calming measures (speed tables and center island) and appropriate signage on Biltmore Dr between Stephens Dr and Clifton Rd in the district; and assess all properties in the affected area of the district an annual \$25.00 maintenance cost after the first year through the life of the traffic calming measures.
