Awarded by the BOC on January 24, 2017 for an amount not to exceed \$1,936,000.00. On March 27, 2018, the BOC approved the 1st renewal option for an amount not to exceed \$1,470,900.00. On April 23, 2019, the BOC approved the 2nd renewal option for an amount not to exceed \$2,500,000.00. This contract consists of improving the roadways by bringing manholes up to DWM standards through adjustments, reinstallations, or replacements.
