### PURPOSE:

Awarded by the BOC on June 26, 2018 to two vendors for a total amount not to exceed \$379,664.00 with an amount not to exceed \$189,832.00 for Rem-Kiks. On June 25, 2019, the BOC approved Change Order No. 1 to the Rem-kiks contract for an amount not to exceed \$110,224.85 for additional funding and ratification of payment for previously rendered services. On June 25, 2019, the BOC approved the 1st renewal option for an amount not to exceed \$324,387.60. The contract for the second vendor was not renewed and funding for that vendor is not referenced herein.
