#### PURPOSE:

To consider adopting the attached resolution consenting to the deannexation from the City of Stone Mountain property located at 694 Ridge Avenue.

To consider authorizing all of the property become a part of unincorporated DeKalb County upon approval of the deannexation ordinance by the City of Stone Mountain; and

Authorize the Chief Executive Officer to execute all necessary documents.

# **NEED/IMPACT:**

The owner of 694 Ridge Avenue desires that the property be deannexed from Stone Mountain into unincorporated DeKalb County. O.C.G.A. § 36-36-22 requires owners of land who desire to deannex property from a municipal corporation to the county where the property lies to submit a written signed application containing a complete description of the property to the city where the property lies and further requires that the county consent to such deannexation. Consent shall be indicated in a resolution. If the attached resolution consenting to the deannexation is adopted, the owners will then apply with the City of Stone Mountain for deannexation via ordinance.

# FISCAL IMPACT:

There is no fiscal impact.
