Awarded by the BOC on August 25, 2015 for an amount not to exceed 2,379,370.00. Change Order No. 1 was approved by the BOC on March 27, 2018 for an amount not to exceed \$381,705.00. Change Order No. 2 was approved by the BOC on July 10, 2018 for an amount not to exceed \$225,000.00. This contract consists of continued software licensing and maintenance support for iasWorld and its Computer Assisted Mass Appraisal (CAMA) module. Maintenance and support includes, but is not limited to, software upgrades, enhancements,
