The McCrometer finished water flow meters are Full Profile Insertion (FPI) Mag Meters that can be installed on the County's preexisting taps to replace the two (2) inaccurate Venturi meters without service interruptions. Purchasing McCrometer finished water flow meters will prevent the County from paying construction cost due to line shutdown.
