Awarded by the BOC on January 27, 2015 for an amount not to exceed \$1,390,303.00. Change Order No. 1 was approved by the BOC on December 10, 2019 for an amount not to exceed \$140,334.16. Change Order No. 2 was approved by the BOC on March 31, 2020 for an amount not to exceed \$46,778.05. This contract consists of the review, approval and tracking of LSBE certifications and the monitoring of contracts to ensure compliance with the DeKalb First LSBE Ordinance.
