#### PURPOSE:

To transfer funds in the amount of \$98,760.48 to the City of Tucker for the Johns Homestead property. Funds will be transferred from the following 2001 Parks Bond accounts:

#### NEED/IMPACT:

The funds are needed by the City of Tucker for the restoration of the John Homestead structure. The building on the Johns Homestead property has structural concerns and the funds will be used to stabilize the structure. The Johns Homestead property is now owned by the City of Tucker, and RPCA will transfer the remaining
