NEED/IMPACT:

The Lessee, PDK Hospitality, Inc. dba Downwind Restaurant & Lounge desires to assign and transfer all of its rights, title and interest in and to its long-term lease to PGH Hospitality, L.L.C. dba Downwind Restaurant & Lounge, a Georgia limited liability company.
