To consider accepting \$197,500.00 from the Georgia Department of Behavioral Health and Developmental Disabilities (DBHDD) for DeKalb County Accountability Courts and appropriating it in a new award in the grant fund

**NEED/IMPACT:**

DBHDD is awarding DeKalb County Accountability Courts \$197,500.00 to be used for treatment coordinator, psychiatric and nursing services, house & medication assistance, counseling services, and drug testing & monitoring services. The grant period is from July 1, 2020 through June 30, 2021, and no match is required
