#### **PURPOSE:**

Pursuant to O.C.G.A. Sec. 20-5-42(a) and the Constitution and Bylaws the DeKalb County Library System, the DeKalb County Board of Commissioners may appoint up to ten (10) member from the public at-large.

Ms. Valerie Boyd is being reappointment to the DeKalb County Public Library Board of Trustees as a member from the public-at-large by t e Board of Commission. This is a four (4) year term to run from January 1, 2021 through December 31, 2024...

#### **NEED/IMPACT:**

The operation of the DeKalb County Public Library is legally vested in the Board of Trustees under the provision of the *Official Code of Georgia Annotated*, Title 20, Chapter 5, Article 40. Per the Constitution and By-Laws of the DeKalb County Public Library eight (8) county appointees from the public at-large serve on the Board of Trustees along with two municipal appointees, the CEO and the Executive Assistant to the CEO. Appointees typically serve four (4) year terms and can be reappointed for a total of three (3) consecutive terms.
