Awarded by the BOC on December 10, 2002 for the purchase of Oracle Applications, a software system for financial management which included technical support services and licensing for the term of the agreement. On March 24, 2009, the BOC approved the annual cost for additional licenses and to renew any license or service expirations for a total amount not to exceed \$619,289.64. On February 9, 2010, the BOC approved the 1st Renewal for an amount not to exceed \$797,184.60. On January 14, 2011, the BOC approved the 2nd Renewal for an amount not to exceed \$930,319.28. On February 28, 2012, the BOC approved the 3rd Renewal for an amount to exceed \$1,029,369.28. On December 11, 2012, the BOC approved the 4th Renewal for an amount not to exceed \$897,685.21. On January 28, 2014, the BOC approved the 5th Renewal for an
