PURPOSE:

Awarded by the BOC on November 14, 2017 for an amount not to exceed \$7,241,636.00. On January 22, 2019, the BOC approved Change Order No. 1 to add a work allowance in an amount not to exceed \$500,000.00. On September 22, 2020, the BOC approved Change Order No. 2 to increase the scope of work, contract term to June 30, 2021, and funding in an amount not to exceed \$1,748,323.00. Due to the impact of the pandemic, labor

and supply shortages of required roofing materials from steel mills have delayed completion of work. This request, to increase the contractor term, will allow the manufacturer the time to receive and install roofing parts needed to continue in the repair of the storage tanks. Completion of this work will contribute to the increase in the volume of available potable water to the County's water system.
