**PURPOSE:**

On September 8, 2020, Purchase Order No. 1224871 was approved in the amount of \$91,120.00 for an emergency purchase for On-Call Electrostatic Disinfectant Vaporized Spraying services for 17 weeks at nine (9) Public Safety facilities through December 31, 2020. This emergency request is for additional funding in the amount of \$133,952.00 for the continuation of services at the same facilities for an additional 26 weeks through July 31, 2021.

**RECOMMENDATION:**

**ADDITIONAL INFORMATION:**

1. Funding: CARES (Police Services)
