PURPOSE:

Awarded by the BOC on October 11, 2016 to four (4) vendors for a total amount not to exceed \$12,000,000.00. On October 23, 2018, the BOC approved an increase in funding to all four (4) contracts for a total amount not to exceed \$6,000,000.00. On November 10, 2020, the BOC approved an increase in funding for Contract No. 1034377 (Arcadis) and the contract term through December 31, 2021 to all four (4) contracts. This request to

increase funding to Contract Nos.: 1034376, 1037379 and 1034381 will allow for the continuation of existing engineering services. Lastly, this request will also ensure there is no lapse in service while new contracts are procured and awarded in 2021. The RFP is currently in the evaluation phase.
