PURPOSE:

Awarded by the BOC on October 11, 2016 to four (4) vendors for a total amount not to exceed \$12,000,000.00. On October 23, 2018, the BOC approved an increase in funding to all four (4) contracts for a total amount not to exceed \$6,000,000.00. On November 10, 2020, the BOC approved an increase in funding for Contact No. 1034377 (Arcadis) and the contract term through December 31, 2021 to all four (4) contracts. This request to
