#### **PURPOSE:**

To consider accepting \$57,970.00 for the DeKalb County Veterans Court from the Criminal Justice Coordinating Council and appropriating the amount to a new Grant Fund.

#### **NEED/IMPACT:**

The Criminal Justice Coordinating Council has awarded \$57,970.00 to the DeKalb County Veterans Court. Funding will be used toward annual conference training, psychiatric & nursing services, counseling services, housing, medication, drug testing & monitoring supplies, and transportation costs for program participants The grant period is from July 1, 2021 through June 30, 2022. The required cash match (\$6,441) will be met through the Superior Court Operating and/or DATE Fund budget.

#### **FISCAL IMPACT:**

Funding for all services provided by Criminal Justice Coordinating Council Grant in the amount of \$57,970.00.
