PURPOSE:

Awarded by the BOC on June 26, 2018 to two vendors for a total amount not to exceed \$379,664.00 with an amount not to exceed \$189,832.00 for Rem-Kiks. On June 25, 2019, the BOC approved Change Order No. 1 for ratification of payment for previously rendered services and the first renewal option for amounts not to exceed \$110,224.85 and \$324,387.60, respectively. The contract for the second vendor was not renewed. On June 23, 2020, the BOC approved the second renewal for an amount not to exceed \$646,944.45. This contract consists of the provision of personal care, homemaker and respite tasks as supportive services to allow seniors to age in place.
