Awarded by the BOC on January 27, 2015 for an amount not to exceed \$1,390,303.00. On December 10, 2019, the BOC approved Change Order No. 1 for an amount not to exceed \$140,334.16. On March 31, 2020, the BOC approved Change Order No. 2 for an amount not to exceed \$46,778.05. On August 25, 2020, the BOC approved Change Order No. 3 for an amount not to exceed \$280,668.30. This contract consists of the review, approval and tracking of LSBE certifications and the monitoring of contracts to ensure compliance with the DeKalb First LSBE Ordinance.
