PURPOSE:

Awarded by the BOC on August 28, 2018 for a total amount not to exceed \$2,010,000.00. On August 27, 2019, the BOC approved the 1st renewal option for an amount not to exceed \$1,500,000.00. On August 25, 2020, the BOC approved the 2nd renewal option for an amount not to exceed \$1,250,000.00. The County is required to inspect over 6,100 structures and over 999,500 linear feet of conveyances each year to comply with NPDES permit requirements. This request is to extend the term of each contract to February 28, 2022 to avoid any interruptions in completing projects.
