#### **NEED/IMPACT:**

Using an integrated marketing communication approach, Profile will create an updated communication plan for DeKalb VRE that will guide general communications activities, establish key objectives, and identify top priorities related to educating DeKalb voters about SB 202 and upcoming elections.

# **FISCAL IMPACT:**

The cost of Profile Marketing Services is \$350,000.00. This amount includes retainer professional services of \$37,5000.00 a month through December 2021 plus up to \$150,000.00 to cover the cost of printing, collateral, advertising, outreach and engagement, translation services and miscellaneous communication needs. This amount is currently reserved in the Voter Registration and Elections Budget Allocations.

To express the Governing Authority's support of this expenditure from the BRE's budgeted operating expenses as a part of the ongoing support effort by the Governing Authority in the BRE's continued and consistent efforts for the benefit of the voters of DeKalb County.
