PURPOSE:

To consider adopting a resolution to set a date and time for a public hearing related to potential abandonment of a 0.066-acre section of Oxford Road NE right of way that has ceased to be used by the public to the extent that no substantial public purpose is served by said right of way.

NEED/IMPACT:

State law requires that a public hearing be held on a potential abandonment of alley.

The adjoining property owner has requested that 0.06-acre section of Oxford Rd NE right of way be abandoned. The subject property is zoned "C-1" and valued at \$64,218.00 by the Property Appraisal Department. Sale of the property would return it to the tax roll. The subject property is no longer needed for right of way purposes by DeKalb County; no substantial public purpose is served by its continued existence.
