On March 23, 2021, the BOC approved Change Order No. 3 to increase the scope of work, contract term through December 31, 2021, and funding in an amount not to exceed \$14,674,232.75. This contract consists of cooperatively purchasing from the competitively let City of Savannah annual contract for the provision of trenchless sewer rehabilitation services.
