<u>PURPOSE:</u>

To consider accepting the annual Victims of Crime Act (VOCA) grant from the Criminal Justice Coordinating Council in the amount of \$648,006 for the District Attorney's Office Victim Assistance Program for the grant year October 01, 2021 - September 30, 2022; and

To consider the continuation of the ten Victim Advocate positions funded by the grant for the grant period, 10/1/21 through 9/30/2022; and

To authorize the CEO to execute all necessary documents.

NEED/IMPACT:

The VOCA grant funds ten District Attorney's Victim Advocate positions who are essential to providing a range of services to victims of crime required by the Crime Victims Bill of Rights, O.G.C.A. 17-17-1, including but not limited to notification of court dates, accompaniment to court, emergency safety planning, counseling, and referrals to community agencies.
