On December 12, 2017, the BOC approved the purchase of this software under a 3-year multi-year contract, for an amount not to exceed \$239,450.00. On November 10, 2020, Change Order No. 1 for an amount not to exceed \$99,715.00 was approved to extend the contract term to December 31, 2021. This Software-As-A-Service is proprietary, and the supplier is the only source that can provide the necessary service and support. This request is to establish a new five (5) year service agreement for the continuous servicing of the RMIS.
