To consider accepting Grant in the amount of \$425,000 from the Office of Juvenile Justice and Delinquency Prevention (OJJDP) to provide comprehensive assessment and services to at risk and offender female youth ages 12-17 in Dekalb County.

#### **NEED/IMPACT:**

The Office of Juvenile Justice and Delinquency Prevention (OJJDP) awarded Dekalb County Juvenile Court \$425,000 to administer S.M.A.R.T Girls. The program will provide early assessment, education advocacy, individualized case planning, referral to appropriate services, evaluation of those services, and follow-up.

The program will serve as an umbrella of services that embrace the individuality of the at risk and female offender by creating services that address her unique needs in a setting that is conducive for her to flourish.
