Consists of piggybacking off the competitively let Region 4 ESC/OMNIA Partners Cooperative Purchasing

Agreement No. R170802 annual contract for the provision of trenchless technology rehabilitation and related services.

These requested services will assist DWM in completing over 360,000 linear feet of unallocated small diameter sewer line rehabilitation services under the Modified Consent Decree. The County will also utilize additional existing contracts, where/if possible, to complete the required linear footage.

The County's resulting contract will be drafted to survive the expiration of the Region 4 ESC/OMNIA Partners Cooperative Purchasing Agreement No. R170802.
