PURPOSE:

To consider approving federal state block funding in the amount of \$148,000 (through the FAA and the Georgia Department of Transportation), as part of the American Rescue Plan Act (ARPA).

To consider authorizing the Chief Executive Officer to execute the necessary documents.

NEED/IMPACT:

As a result of the Covid-19 pandemic, the County and the Airport will receive \$148,000 from the FAA's state block grant program, as part of the American Rescue Plan Act (ARPA).

The funding is in the amount of \$148,000. The distribution will be provided at a 100% federal share with no local match required.

The funding can be spent immediately to help minimize any adverse impact from the current Covid-19 health emergency.
