Awarded by the BOC on March 12, 2019 for a total amount not to exceed: \$942,000.00. On August 27, 2019, the BOC approved Change Order No. 1 for a total amount not to exceed \$109,238.58. On January 28, 2020, the BOC approved the 1st renewal option for a total amount not to exceed \$1,251,238.58. On February 23, 2021, the BOC approved the 2nd renewal option for a total amount not to exceed \$1,082,738.58. On March 31, 2022, the CPO approved an emergency request for a total amount not to exceed \$350,412.86 and to extend the contract through June 30, 2022.
