#### **PURPOSE:**

To approve an appropriation of \$25,000 from the American Rescue Plan grant funds assigned to the account reserved for District 7 to One Powerhouse for the purpose of providing rent, mortgage and utility assistance to mitigate the public health emergency created by the COVID-19 pandemic.

### **NEED/IMPACT:**

There is a need for rent, mortgage, utility and food assistance due to the loss of employment and wages of DeKalb residents impacted by the COVID-19 pandemic. DeKalb residents have experienced financial distress, lack of adequate food, the inability to pay utilities, evictions, and the loss of basic housing security. COVID-19 has exacerbated an environment of anxiety and financial uncertainty for individuals and families in DeKalb communities.
