### PURPOSE:

To increase revenue anticipations for the Special Tax District - Designated Services Fund by \$18,671,641; to appropriate \$4,525,000 to Public Works - Roads & Drainage; and to appropriate \$14,092,641 to the Special Tax District - Designated Services Fund - Budgetary Reserve.

### NEED/IMPACT:

This amendment to the operating budget for the Roads & Drainage Division of Public Works provides additional funds to cover higher costs for professional services and supplies, personal services adjustments, and a traffic sign maintenance project. This additional funding will also allow Roads & Drainage to purchase replacement office trailers.

The increase in revenue anticipations reflect the effects of the adopted 2022 millage rate and other updated

revenue projections for the Special Tax District - Designated Services Fund.

**FISCAL IMPACT:**

Increase revenue anticipations for the Special Tax District - Designated Services Fund (various line items) by \$18,617,641.

Increase appropriations for Public Works - Roads & Drainage - Special Tax District - Designated Services Fund (various line items) by \$4,525,000.

Increase appropriations for Fund Reserves - Special Tax District - Designated Services Fund - Budgetary Reserve by \$14,092,641.

**RECOMMENDATION:**

To approve the resolution and authorize the chief executive officer to execute all necessary documents.
