PURPOSE:

Awarded by the BOC on August 27, 2019, for an amount not to exceed \$990,510.04. On June 14, 2020, the BOC approved the 1st renewal for an amount not to exceed \$1,261,138.40. On June 22, 2021, the BOC approved the 2nd and final renewal for an amount not to exceed \$1,038,171.08. On November 11, 2021, an Emergency Purchase was awarded to American Eagle, LLC for Groups II and III. On December 14, 2021, BOC approved the cancellation of DeAngelo Brothers, LLC contract due to the company ceasing operation. On August 2, 2022, the BOC approved Change Order No. 1 for an amount not to exceed \$342,059.22.
