Awarded by the BOC on August 27, 2019 to two vendors in a total amount not to exceed \$990,510.04. On June 14, 2020, the BOC approved the 1st renewal to both vendors in a total amount not to exceed \$1,261,138.40. On June 22, 2021, the BOC approved the 2nd renewal to both vendors in a total amount not to exceed \$1,038,171.08. On November 11, 2021, an Emergency Purchase was awarded to American Eagle, LLC for Groups II and III for an amount not to exceed \$343,843.50. On August 2, 2022, the BOC approved Change
