PURPOSE:

To approve the appropriation of \$76,500 from the America Rescue Plan grant funds assigned to the account reserved for a District 7 to the DeKalb County Human Services Department for the development of the DeKalb County E.M.B.A.R.C. Community Youth Farm youth entrepreneurial and training program and all eligible uses to mitigate the negative impacts caused by the COVID-19 pandemic on DeKalb County families and youth.

NEED/IMPACT:

The DeKalb County E.M.B.A.R.C. Community Youth Farm will engage youth in urban agriculture entrepreneurship, farming, and programming. The program is needed to train youth and develop critical skills, knowledge and preparation for employment and upward mobility to mitigate the negative impacts caused by the COVID-19 pandemic.
