The agenda item was withdrawn to make revisions to the current purpose of the PWI Committee on the DeKalb County website: **PWI has the authority to handle all subjects regarding matters of countywide public works services and the effective provision of departments associated allocation of costs.**

Commissioner Terry will be collaborating with the Law Department and PWI Committee members to add additional language to include the authority over all subjects regarding **Environmental Justice** matters including mitigating exposure from hazardous waste, resource extraction, and other land uses from which marginalized communities do not receive benefits.
