PURPOSE:

(1) To consider approving the FY23 Homeland Security Grant Program (EOD K9)/Georgia Emergency Management and Homeland Security Agency (GEMA/HS) funding; and

(2) To consider accepting \$18,500.00 from the Georgia Emergency Management and Homeland Security Agency (GEMA/HS) and appropriating \$18,500.00 to the grant fund for spending in compliance with the grantor's requirements; and

NEED/IMPACT:

This grant will be dedicated to the Special Services Division for the purchase of dog food and veterinary care for the EOD K9s.
