On April 14, 2020, the BOC approved Change Order No. 2 for additional funds to comply with the State of Georgia's new Category 1 dam ownership requirement. These contracts consist of the provision of professional engineering and design services for localized drainage repair, stormwater improvement, bridge repair and other related civil engineering projects.
